Membership: 189 professionals, 79 students, 9 fellows, 6 life members, total: 283. We were 307 for all of 2016, so we are killing it.

PDH Credits: PDH form was given to Randy, so we are all set up.

Future Meetings: Key Largo meeting topics are coming together, we will do the silent fund raiser again. Riviera Beach location – The planning committee checked on the tiki bar, food, location, and it did not look good enough for our group. Plus, the local contact is unresponsive. Sam Palermo is looking at other venues. Agenda is looking good. November: Stetson, no details yet, Ray Scott is putting that together with assistance from The Balmoral Group.

Next Year: back in Fort Myers (Kellie is going to help), should we think about another Tallahassee again, Gainesville. FSU vs UF rivalry?, Jacksonville. Sanford? Streamsong? Camp Weed?

Unfinished Business: No need to continue to talk about Annual Sponsorship.
